UNDERGROUND PROTECTED TANK - USA

30-YEAR LIMITED WARRANTY CERTIFICATE

Each steel storage tank designed for underground storage purposes, manufactured by Granby Steel Tanks hereinafter called "GST" or "the warrantor" and bearing the label ULC S603.1 and embossed nameplate showing manufacturer's serial number, is warranted by GST against:

- a) non-corrosion failure due to defective materials and workmanship, for a period of one (1) year after date of delivery of the tank to the purchaser;
- b) failure due to exterior corrosion caused by reaction of the tank with its soil environment, for a period of thirty (30) years from date of delivery of the tank to the purchaser. Each such limited warranty is subject to the following conditions:

1. The tank must be installed in accordance with the latest Edition of ULC S603.1m standard in accordance with GST installation Manual for Protected underground Storage Tank and under authorities having jurisdiction.
2. Electrical conductivity of soil environment at the installation site must be reasonably consistent in Ph, with a resistance of 2000 ohms.cm up to 15,000 hms.cm, and must be free of stray current.
3. Non-conductive bushings furnished with the tank must be used for all connections of the piping system with the tank. The tank must not be grounded to other metallic structures.
4. In the event of tank failure due to exterior corrosion, the purchaser must promptly inform GST so as to permit a representative of GST to inspect the tank site prior to and during excavation, and the tank after it is excavated. The purchaser shall confirm to GST such notice in writing.
5. The obligation of warrantor under this warranty is limited to supply F.O.B. plant a replacement of approximately the same size, design quality of material and workmanship as the original tank, and the purchaser shall pay for the replacement tank on a prorated basis according to the period of time that has elapsed since the delivery of the original tank, as follows.
 First 20 years – no charge
 From the first to the last day of the twenty first year: 10 % of the current price of the replacement tank.
 Twenty second year: 20%; and an additional 10% each succeeding year until thirtieth year when the purchaser will be charged 90% of the current price of the replacement of tank.
6. The warrantor shall not be liable for labour of other installation costs of any replacement tank furnished in accordance with the terms of this limited warranty. In any event, the warrantor shall not be liable for the contents of the tank.
7. The warrantor shall not be liable for failure of the piping system connected with any tank nor for any consequential damages to person of property resulting from, or attributed to, the failure of any tank of the connection piping system, regardless of cause of failure.
8. Such limited warranty will be valid and will be honoured by GST if the protection system testing instructions are followed and if the potential record is duly completed in accordance with GST Installation Manual for Protected Underground Storage Tank. Any potential reading which indicates that cathodic protection is not adequate shall be immediately reported to GST and confirmed in writing.
9. Should any of the foregoing clauses of this limited warranty be held to be invalid under the applicable existing Laws of the place of purchase, such a clause will be considered merely void and severable and will in no way affect the validity of the remaining clauses of this limited warranty.
10. THE FOREGOING LIMITED WARRANTY IS THE ONLY WARRANTY MADE BY THE WARRANTOR. ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE OTHER THAN THAT FOR WHICH THE TANK HAS BEEN DESIGNED AND ANY OTHER REPRESENTATIONS OF ANY KIND ARE HEREBY DISCLAIMED BY THE WARRANTOR AND EXCLUDED FROM THE AGREEMENT OF SALE.
